LS4EU Children of Immigrants Longitudinal Survey in Four European Countries

## THEME

The Children of Immigrants Longitudinal Survey in Four European Countries (CILS4EU) provides a unique data source to study integration processes among immigrant adolescents in England, Germany, the Netherlands and Sweden. Given the survey's broad scope, CILS4EU-data comprise a wide array of information on different aspects of the cognitive-cultural (e.g., language skills and usage), structural (e.g., educational and occupational success), social (e.g., friendship formation or partner choices) and emotional-cultural dimension of integration (e.g., religion or identity). In addition, following in the footsteps of the CILS4EU-project, surveys among immigrant adolescents have been conducted in Belgium and Norway. With the CILS4EU and comparable surveys becoming more and more popular, the 2nd CILS4EU User Conference offers users the opportunity to present their current research based on CILS4EU-data (completed or ongoing), to share their experiences, and to get into contact with the international CILS4EU-team.
